Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, this corporation adopts the following articles of amendment to its articles of incorporation:

FIRST: The name of the corporation is:

Q-Link Technologies, Inc.

SECOND: Article V of the Corporation's Articles of Incorporation is amended in its entirety as follows:

Article V. Capital Stock

The total number of shares of capital stock which the Corporation shall have the authority to issue shall be 200,000,000 shares, of which 100,000,000 shares shall be Common Stock having a par value of \$0.001 per share and 100,000,000 shares of preferred stock having a par value of \$0.001 per share. Pursuant to Section 607.0602 of the Florida Business Corporation Act, the Board of Directors is authorized, without the approval of the shareholders of the Corporation, to (a) provide for the classification and reclassification of any unissued shares of common stock or preferred stock and determine the preferences, limitations, and relative rights thereof and (b) issue common stock or preferred stock in one or more classes or series, all within the limitations set forth in Section 607.0601 of the Florida Business Corporation Act.

THIRD: The date of adoption for the above amendments is February 1, 2001.

FOURTH: The above amendment was approved by the shareholders. The number of votes cast for the amendments were sufficient for approval.
