## ARTICLES OF INCORPORATION

OF

# LAW OFFICES OF WILLIAM L. LEE, JR., P.A.

The undersigned Incorporator, files these Articles of Incorporation in order to form corporation under the Florida General Corporation Act.

## ARTICLE I. CORPORATE NAME

The name of this corporation shall be Law Offices of William L. Lee, Jr., P.A.

# ARTICLE II. NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted by this corporation is to engage in any and all business permitted under the laws of the State of Florida.

#### ARTICLE III. TERM OF EXISTENCE

This corporation shall exist perpetually unless dissolved according to law.

#### ARTICLE IV. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to issue and have outstanding at any one time is 500 shares of common stock having a par value of \$1.00 per share.

Every shareholder, upon the sale of any shares or securities of the corporation convertible into or carrying a right to subscribe to share of this corporation of the same kind, class, or series as that which he holds, shall have the right to purchase his pro-rata share at the price at which it is offered to others.

# ARTICLE VI. REGISTERED AGENT AND INITIAL REGISTERED OFFICE

#### ARTICLE VII. BOARD OF DIRECTORS

This corporation shall have one director initially. The number of directors may be increased or diminished from time to time by By-Laws adopted by the stockholders, but shall never be less than one.
