ARTICLE I

Name and Principal Office

The name of this corporation is FALCOM COMMUNICATIONS, INC. The principal place of business and mailing address of this corporation is 13 Northeast First Avenue, Ocala, FL 34470.

ARTICLE II

Duration

This corporation shall have perpetual existence commencing on the date of execution and acknowledgment of these Articles.
