ARTICLE I - NAME, PRINCIPAL ADDRESS AND MAILING ADDRESS

The name of the Corporation shall be CHELATION MEDICAL CENTERS, INC. The principal and mailing address of the corporation shall be 6110 9th Street North, St. Petersburg, Florida 33703.

ARTICLE II - NATURE OF BUSINESS

The business is being formed for the purpose of rendering medical services and any other services as may be authorized by law.

ARTICLE III - CAPITAL STOCK

The Corporation is authorized to issue one thousand (1000.00) shares of capital stock of the par value of One Dollar (\$1.00) which shall be designated "Common Shares," and all of which shall have the same rights and privileges.


ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT


