ARTICLE I - NAME & ADDRESS

The name of this corporation is Mahagan Clinic, P.A.. The mailing address of the corporation is 4700 9th Avenue North, St. Petersburg, Florida 33713.

ARTICLE II - PURPOSE

The purpose of this corporation shall be as follows:

- 1) A medical clinic specializing in preventive medicine and weight control;
- 2) In general, to have and to exercise all powers conferred by the laws of the State of Florida upon professional service corporations and to do any and all things hereinabove set forth to the same extent as a natural person might or could do.

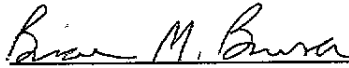
ARTICLE VII - INDEMNIFICATION

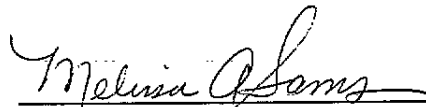
