- Name. The name of this corporation is MACABEE REALTY, INC. 1.
- Duration. The period of its duration is in perpetuity. 2.
- The purpose is to engage in any activities or 3. Purpose. business permitted under the laws of the United States and Florida.
- Capital Stock. The corporation is authorized to issue 1,000 4. shares, all of one class, at .01 par value.
