ARTICLES OF INCORPORATION

The undersigned, acting as incorporator and desiring to organize a corporation pursuant to the laws of the State of Florida, signs the following Articles of Incorporation:

ARTICLE I

NAME AND ADDRESS: The name of the corporation is Dispatch Control, Inc. and its principal office and mailing address is 501 Brickell Key Dr. Suite 406, Miami Fl. 33131

ARTICLE II

DURATION: The term of existence of the corporation is perpetual.

ARTICLE III

PURPOSE: This corporation is organized for the purpose of transacting any and all lawful businesses for which corporations may be incorporated under Chapter 607, Florida Statutes, as now exists or may be after amended.

ARTICLE IV

CAPITAL STOCK: The aggregate number of shares that the corporation has authority to issue is One Thousand (1,000) Shares of Common Stock having a par value of One Dollar (\$1.00) per share.

ARTICLE V

PREEMPTIVE RIGHTS: Each shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which is already held, shall have the right to purchase their pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VI

RESTRICTION OF STOCK TRANSFER: If any shareholder at any time desires to sell, transfer, encumber, or otherwise dispose of his shares of the corporation, he shall first offer his shares to the corporation and then to the shareholders at the price at which it is offered to others.

ARTICLE VII

1244 STOCK: The shares of this corporation are to be issued pursuant to the provisions of Section 1244, Title 26 of the Internal Revenue Code.

ARTICLE VIII

PENSION AND PROFIT SHARING PLAN: In furtherance, and not in limitation of the general powers conferred by the laws of the State of Florida and purpose and objectives hereinbefore stated, the corporation shall have the power to enter into, for the benefit of its employees, one or more of the following: (1) a pension plan, (2) a profit sharing plan, or (3) other retirement or incentive compensation plan.

ARTICLE IX

AMENDMENTS: The corporation reserves the right to amend or repeal any provision in these Articles or any amendment thereto.
