# Articles of Incorporation of George A. Woerner, Inc.

The undersigned, acting as the sole incorporator, desiring to form a corporation for profit pursuant to the Florida Business Corporation Act, adopts the following Articles of Incorporation:

# ARTICLE I - NAME OF CORPORATION

The name of the corporation shall be GEORGE A. WOERNER, INC.

# **ARTICLE II - TERM OF EXISTENCE**

The corporation shall begin its corporate existence as of the filing of these Articles of Incorporation and shall exist perpetually.
