ARTICLE I - NAME

The name of this corporation is Douglas J. Warsett,
M.D., P.A.

ARTICLE II - PRINCIPAL OFFICE

This corporation is organized for the purpose of
rendering specific professional service as medical doctors.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 7,500 shares
of \$1.00 par value common stock which shall be

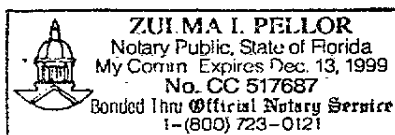
