**ARTICLES OF INCORPORATION
OF
THOMAS J. SCHULTE, D.C., PROFESSIONAL ASSOCIATION**

The undersigned incorporator is licensed or otherwise legally authorized to practice the profession of chiropractic medicine in the State of Florida with the intention of forming a professional corporation in accordance with the Florida Professional Service Corporation and Limited Liability Company Act, and adopts the following articles of incorporation for the corporation:

ARTICLE I - NAME

The name of the corporation is THOMAS J. SCHULTE, D.C., PROFESSIONAL ASSOCIATION

ARTICLE II - PRINCIPAL OFFICE AND INITIAL REGISTERED AGENT

The address of the corporation's principal office is 291 South Collier Boulevard #109, Marco Island, Collier County, state of Florida 34145. The name of the initial registered agent of the corporation, located at that office, is Thomas J. Schulte, D.C.

ARTICLE III - EFFECTIVE DATE AND DURATION

Effective date of the corporation is to be January 1, 1998. The period of duration of the corporation is perpetual, or until dissolved on a vote of the shareholders as provided in these articles.

ARTICLE IV - PURPOSE

The purpose of the corporation is to practice the profession of chiropractic medicine. The sole and exclusive professional service to be rendered by the corporation is chiropractic medicine.

ARTICLE V - CAPITAL STOCK

The total number of shares of stock which the corporation shall be authorized to issue or have outstanding at any one time is One Thousand (1,000) shares. These shares shall be of a single class of common stock, and shall have a value of One Dollar (\$1.00) per share.

ARTICLE VI - CAPITALIZATION

The amount of capital with which the corporation will begin to practice the profession of chiropractic medicine is not less than One Thousand Dollars (\$1,000.00).

ARTICLE VII - CORPORATE POWERS

The corporation shall have all the rights and powers now or subsequently conferred on professional corporations by the State of Florida including, but not limited to, the power to invest its funds in real estate, mortgages, stocks, bonds or any other type of investment, or ownership of real or personal property necessary for the rendering of the professional services for which the corporation is

ARTICLE VIII - INCORPORATORS

The name and street address of each person signing these articles of incorporation as an incorporator is:

ARTICLE IX - DIRECTORS

The corporation is to be managed by a board of directors. The number of directors constituting the initial board of directors is one (1) and the name and address of the initial director is:

The initial director shall hold office until his successor is elected and qualified as provided in the bylaws. Then the term of office of each director shall be one (1) year and until the election and qualification of a successor. The number of directors set forth in these articles of incorporation and constituting the initial board of directors shall be the authorized number of directors until that number is changed by a bylaw duly adopted by the shareholders.

ARTICLE X - BYLAWS


The initial director shall submit the proposed bylaws to the shareholders at a meeting to be held for that purpose not more than thirty (30) days following the issuance of the Certificate of Incorporation. Following the adoption of bylaws by the affirmative vote of a majority of the shareholders, the internal affairs of the corporation are to be regulated and managed in accordance with the bylaws.

ARTICLE XI - DISSOLUTION

The corporation may be dissolved at any time (1) by unanimous written consent of the shareholders; or (2) on the affirmative vote of the holders of a majority of the outstanding shares of the corporation entitled to vote. On dissolution, the corporate property and assets shall, after payment of all debts of the corporation, be distributed to the shareholders pro rata, each shareholder to participate in the distribution in direct proportion to the number of shares held by the shareholder.
