**ARTICLE I - NAME**

The name of this corporation, formed under the provisions of Section 621, Florida Statutes, is RICHARD DUNN, P.A.

**ARTICLE II -- PRINCIPAL OFFICE**

**ARTICLE III - PURPOSE**

The aggregate number of shares which this corporation shall have authority to issue is One Thousand (1000) shares of common stock, all of which are to have a par value of One Dollar (\$1.00).


ARTICLE X -- INDEMNIFICATION
