ARTICLES OF INCORPORATION OF SPOTLITE MULTIMEDIA, INC. A Florida Corporation



Pursuant to Section 607.0201 of the Florida Business Corporation Act, the Articles of Incorporation of Spotlite Multimedia, Inc., a Florida corporation, are as follows:

ARTICLE I NAME

The name of the corporation is Spotlite Multimedia, Inc. (the "Corporation").

ARTICLE II MAILING ADDRESS

The mailing address of the Corporation is 2653 S.W. 23rd Street, Miami, Florida 33145, Attn: Christopher M. Nelson.

ARTICLE III CAPITAL STOCK

The number of shares of stock that the Corporation is authorized to issue is One Hundred (100) shares of common stock, par value \$.01 per share (the "Common Stock"). Each issued and outstanding share of Common Stock shall be entitled to one vote on each matter submitted to a vote at a meeting of the shareholders of the Corporation.
