ARTICLES OF INCORPORATION OF

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARITCLE ONE - NAME

The name of the Corporation is **Professor Watts Electric Service, Inc.**

ARTICLE TWO - DURATION

This corporation shall have perpetual existence effective January 2, 1998.

ARTICLE THREE - PURPOSE
