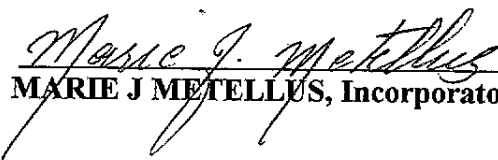
ARTICLE 12- EFFECTIVE DATE
