The undersigned sole incorporator, being a natural person competent to contract and desiring to form a corporation under Title XXXV, Chapter 607 of the revised Florida Statutes, herewith submits the following information:

1. The name of the corporation is:

2. The duration of the corporation shall be perpetual.
3. The general purpose for which this corporation is being formed are to include transaction of any or all lawful business for which the corporation may be incorporated under this chapter. 
