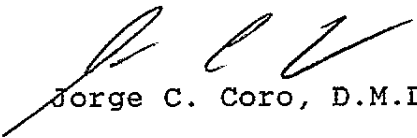

territory or nation., and practice of Orthodontics.

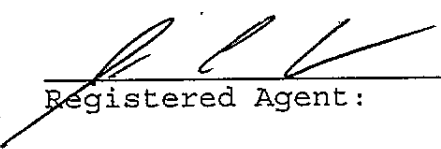
ARTICLE III. CAPITAL STOCK

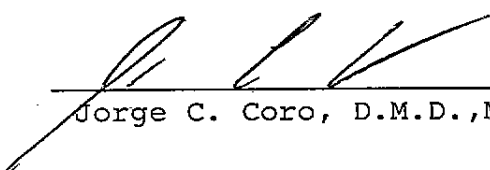

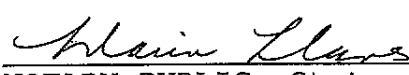

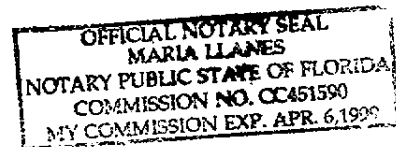
