ARTICLES OF INCORPORATION

of

SPACE COAST NATURE EDUCATE-TOURS, Inc.

The undersigned does hereby file the following pursuant to Florida Statute and does hereby certify that they have become a corporation for profit under and pursuant to the following Articles of Incorporation.

ARTICLE I

The name of the corporation is SPACE COAST NATURE EDUCATE-TOURS, Inc.

Having as its principle office :
4747 S. Washington Ave. #151, Titusville, FL 32780

ARTICLE II

The general character of the business to be transacted by said corporation shall be and is as follows :

To engage, in the business of doing all matters necessary to conduct and carry on a tour business in general, with special emphasis on guiding nature based boat tours and do all things incidental thereto.

To acquire, by purchase, lease or otherwise, lands or interest in lands, to own, hold improve, develop, any real estate so acquired, and to erect, or cause to be erected, on any lands owned, held or accepted by the corporation, buildings or other structures, public or private, with their appurtenances, and to manage, operate, lease, rent, rebuild, enlarge alter or improve any buildings or other structures, now or hereafter erected on any lands so held, or occupied, and to encumber or dispose of any lands, or interest or interest in lands, any building or other structures, at any time owned or held by the corporation. To buy, sell, mortgage, exchange, lease, hold for investment or otherwise, use and operate, real estate of all kinds, improved or unimproved, and any right or interest therein.

To acquire, by purchase, lease, manufacture, or otherwise, any personal property deemed necessary or useful in the equipment, furnishings, improvement, development or management of any property, real or personal, at any time owned, held or occupied by the corporation, and to invest, trade, and deal in any personal property deemed beneficial to the corporation, and to lease, rent, encumber or dispose of any personal property at any time owned or held by the corporation.

To buy and sell all kinds of property, both real and personal; to borrow money, issue promissory notes and other evidence of indebtedness; to own, buy, mortgagee, sell, or otherwise dispose of, and to deal in and with property of all kinds, as well as capital stock and shares of this corporation and that of other corporations, and to vote any share of such other corporations as maybe owned by it, the same as a natural person might do, and to enter into such agreements, contracts, and stipulations and make such arrangements as may be or seem necessary to carry out the same, and to attain the objects and purposes herein expressed and intended; and to transact any further and other business necessarily connected with the purpose of this corporation, or calculated to facilitate the same.

To become a member of enter into any partnership or agreement for sharing profits with any person, firm, or corporation.

To carry on any or all of its operations and businesses, and to promote its objectives within the State of Florida or elsewhere, without restriction as to place or amount; and to have, use, exercise and enjoy all of the general powers of like corporations.

To do any or all of the things herein set forth to the same extent as natural persons might or could do, and in any part of the world as principles, agent, contractors, or otherwise, alone, or in company with others, and to do and perform

all such other things and acts as may seem necessary, profitable, or expedient in carrying on any of the business or acts above-named.

The intention is that none of the objections and powers as hereinabove set forth, except where otherwise specified in these Article, shall be in anywise limited or restricted by reference to or inference from the terms off any other objects, powers or clauses of this Article or any other Article in these Articles of Incorporation, but that the objects and powers specified in each of the clauses in this Article shall be regarded as independent objects and powers.

ARTICLE III

The authorized capital stock shall consist of 100 shares of common stock having a par value of \$1.00 per share, for a total authorized capital stock of 100 shares.

It is the intention of the incorporators that the stock of this company shall qualify as Small Business Company Stock under Section 1244 of the Internal Revenue Code.

ARTICLE IV

The amount of capital with this corporation shall and does hereby begin shall be and is the sum of FIVE HUNDRED (\$500.00) DOLLARS.

ARTICLE V

The corporation shall have a perpetual existence.

ARTICLE VI

The principle office of this corporation shall be and is located in Brevard County, State of Florida. Said corporation, however, may establish branch offices in any other place or places, and may change the place of principle office as and when it is deemed advisable by its Board of Directors. The street address of the principle office of this corporation is 4747 South Washington Avenue, Titusville, FL 32780.

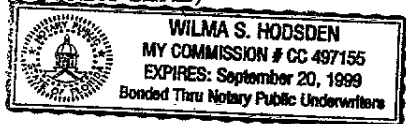

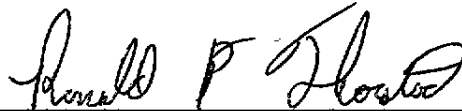
