ARTICLE I - NAME

The name of this Corporation shall be C. J.'s OF MIAMI, INC.

The Corporation shall have a perpetual existence.



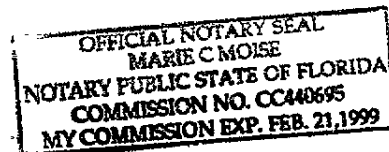
