ARTICLES OF INCORPORATION
OF

The undersigned incorporator delivers these Articles of Incorporation in order to form a corporation under the Florida Business Corporation Act.

ARTICLE I

Name

The name of the Corporation shall be SLAWSONGS, INC.

ARTICLE II

Principal Office

The principal office of the Corporation is located at 440 E. Merrimac Drive, Merritt Island, Florida, and its mailing address is 440 E. Merrimac Drive, Merritt Island, Florida, 32952.

ARTICLE III

Corporate Purposes, Power and Rights

The purpose of the Corporation is to engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV

Duration of the Corporation




