**ARTICLES OF INCORPORATION  
OF  
SALTSMAN & ASSOCIATES, P.A.**

The undersigned incorporator makes, subscribes, acknowledges and files with the Department of State of Florida these Articles of Incorporation for the purpose of forming a corporation for profit under the laws of the State of Florida.

**ARTICLE I**

**NAME**

The name of the corporation is Saltsman & Associates, P.A.

**ARTICLE II**

**TERM OF EXISTENCE**

This corporation shall commence as of the date of the filing of these Articles of Incorporation with the Secretary of State and shall have perpetual existence.

**ARTICLE III**

**NATURE OF BUSINESS**

The purpose for which this corporation is organized is to engage in any acts or activities for which a professional association may be organized under the laws of the United States of America and under Chapter 607 of the Florida Statutes.

**ARTICLE IV**

**CAPITAL STRUCTURE**

All stock when issued shall be paid for and shall be non-assessable.

## **ARTICLE V**

### **INITIAL REGISTERED AGENT AND REGISTERED OFFICE**

The initial registered agent of this corporation shall be Robert P. Saltsman. The street address of the initial registered office of this corporation is 222 W. Comstock Avenue, Suite 210, Winter Park, Florida 32789. The board of directors from time to time may move the registered office of the corporation to any other address in the State of Florida.

### BYLAWS

## ARTICLE XI

### AMENDMENT TO ARTICLES OF INCORPORATION

These Articles of Incorporation may be amended any time by a resolution adopted by a majority vote of the board of directors at any annual or special meeting, provided at least ten (10) days' written notice is given to each director at the time and place of the meeting and the purpose thereof. Any amendment of these Articles of Incorporation so made must be approved by a majority vote of the shareholders of the corporation.


