ARTICLE ONE

The name of the corporation is Seabreeze Landscape Maintenance and Irrigation, Inc. The principal mailing address is 431 Wildmere Avenue, Longwood, Florida 32750.

ARTICLE TWO

The period of its duration is perpetual.

ARTICLE FIVE

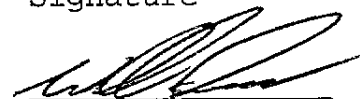
The corporation will not commence business until it has received for the issuance of shares consideration of the value of \$1,000 consisting of money, labor done or property actually received.
