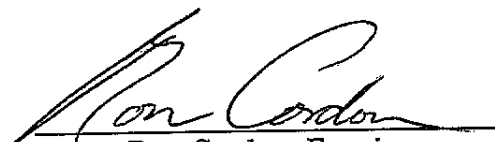

ARTICLE I - NAME

The name of this Corporation shall be JOSEPH BUSINESS CENTER, INC..

ARTICLE II - DURATION

The Corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

The purpose of this Corporation is to engage in any activities or business permitted under the laws of the United States and of the State of Florida.
