**ARTICLES OF INCORPORATION
OF
STEFF'S STUFF, INC.**

The undersigned hereby makes, subscribes, acknowledges, and files these Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida.

Article 1. Name: The name of the corporation is Steff's Stuff, Inc., and its principal office and mailing address is 308 Alhambra Circle, Coral Gables, Florida 33134

Article 2. This corporation shall have perpetual existence which shall commence upon the filing of these Articles with the Department of State.

Article 3. This corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.

Article 4. The capital stock of this corporation shall consist of 5,000 shares of common stock of \$1.00 par value each, all or part of said stock to be issued from time to time as may be determined by the Board of Directors. There shall be no pre-emptive right granted to the stockholders with respect to the shares of the corporation. On dissolution or liquidation of the corporation, holders of the stock shall be entitled to distribution ratably as their holdings may appear upon the stock records of the corporation.

Article 5. The initial registered agent of this corporation and his address is as follows: Thomas P. Finan, Esquire, 8403 Rednock Lane, Miami Lakes, Florida 33016.

Article 6. The number of directors of this corporation shall not be less than one (1), but the by-laws may provide for the increase or decrease in the number thereof, provided that the number of directors shall never be less than one (1).

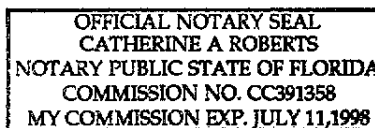
