
Please be advised we are in receipt of your letter dated May 16, 2001 regarding the copy of the report we filed which was forwarded to you prior to our receiving our FEI # for the corporation. As we did, in fact, mail an SS-4 application to obtain same when the corporation was first formed and due to the fact there are no employees, we were unaware we, apparently, had not received an FEI # from the IRS until we received the above referenced letter from your office.

Further, please advised, we chose to and have attempted on numerous occasions, since your May 16<sup>th</sup> notification, to telephone the IRS to obtain a Federal I.D. number as our initial application to and/or response from the I.R.S. was apparently lost in the U.S. mail transition. Unfortunately, we were unable to reach even a voice message which gave instructions for faxing the application until last week – the prior recorded answer simply instructing the caller to attempt to reach them at a later and less busy time and an immediate end to the call connection.

We have enclosed the copy of the report provided by your office which now includes our newly assigned FEI # and are requesting the \$400.00 late fee be waived. We were unable to provide a copy of the first FEI number application as the original was mailed, therefore, we were forced to simply continue to attempt to reach the IRS directly, again, with no success. This must be a common issue among various corporations and/or businesses as it has become almost impossible to reach the number given to obtain the FEI # from the IRS.

Again, we request the \$400.00 fee be waived as the renewal fee of \$150.00 was, in fact, paid and sent through our bank account well before your notification the report had not been filed. Please accept the 2001 Uniform Business Report with FEI number 59-3731155 provided as, again, payment in the amount of \$150.00 was long ago forwarded, - accepted, and deposited. Thank you.
