ARTICLES OF INCORPORATION
OF
ANDERSON SIDING SPECIALTY CONTRACTORS, INC.

ARTICLE I

The name of this corporation is: **ANDERSON SIDING SPECIALTY CONTRACTORS, INC.**

ARTICLE II

The term of existence of the corporation is perpetual.

ARTICLE III

The purpose of this corporation is to install vinyl siding in homes and commercial buildings and to construct and remodel residential and commercial buildings and all other lawful business.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 1,000 shares of \$1.00 par value common stock.

ARTICLE V - PRE EMPTIVE RIGHTS

Each shareholder upon the sale for cash of any new stock of this corporation of the same kind, class or series of that which he already holds, shall have the right to purchase his pro rata share (as nearly as may be done without issuance of fractional shares) at the price of which it is offered to others.

ARTICLE VI - INITIAL REGISTERED
