ARTICLE I. CORPORATE NAME

The name of this Corporation is Produra Technologies, Inc.


ARTICLE XI. PRE-EMPTIVE RIGHTS

ARTICLE XII. INDEMNIFICATION


This Corporation shall indemnify any officer or director or any former officer or director, to full extent permitted by law.
