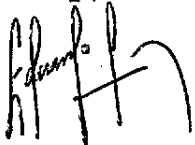

ARTICLES OF INCORPORATION

OF

JOSE M. BIBILONI, P.A.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of this corporation is JOSE M. BIBILONI, P.A.

ARTICLE II - DURATION

The term of existence of the corporation is perpetual.

ARTICLE III - PURPOSE

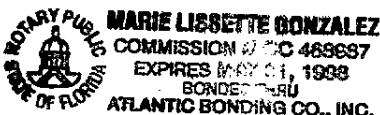

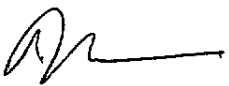
