### ARTICLE I - NAME EFFECTIVE DATE 1/1/98



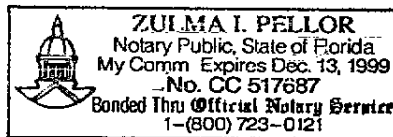
