4. The registered agent of the corporation is Clifford D. Smith and the registered street address is 3622 Barrancas, Ave. Pensacola Florida 32507.

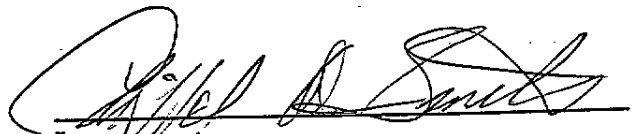

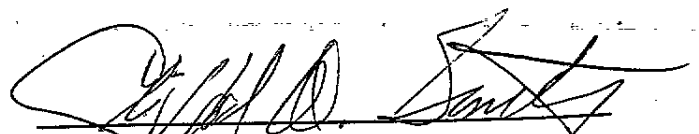
