### **ARTICLE I-NAME**

**ARTICLE XI-RESTRICTIONS ON THE TRANSFER OF STOCK**

**ARTICLE XII-CUMULATIVE VOTING**

At each election for directors, each shareholder entitled to vote at such election shall have the right to cumulate his votes by giving one candidate as many votes as the number of directors to be elected at that time multiplied by the number of his shares, or by distributing such votes on the same principle among any number of such candidates.

**ARTICLE XIII-CALLING OF SPECIAL MEETINGS**

Special meeting of the shareholders may be called by the Board of Directors.


**ARTICLE XIV-SHAREHOLDERS QUORUM AND VOTING**


