ARTICLES OF INCORPORATION OF MGSR, INC. 98 JAH-2 AM 9: 15

The undersigned, for the purpose of forming a corporation of for profit, files these Articles of Incorporation with the Secretary of State of the State of Florida, pursuant to the Florida Business Corporation Act of the State of Florida, Chapter 607, Florida Statutes.

- 1. NAME. The name of the corporation is MGSR, INC. (the "Corporation").
- 2. <u>ADDRESS</u>. The street address and the mailing address of the initial principal office of the Corporation is 4109 W. Mullen Ave., Tampa, FL 33609.
