

The undersigned incorporator to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation for profit under the laws of the State of Florida.

ARTICLE I.

NAME: The name of this corporation shall be Tape and Mastic, Inc.

ARTICLE II.


ARTICLE X.

The undersigned incorporator has executed this Articles of Incorporation this 1st day of January, 1998.


