

## ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF ANDREW L. ADELSON, D.D.S., P.A., a Florida corporation



Pursuant to the Florida Business Corporation Act, Article II of the Articles of Incorporation of Andrew L. Adelson, D.D.S., P.A., a Florida corporation, hereinafter referred to as the "Corporation", is amended in its entirety to read as follows:

## ARTICLE IL PURPOSE

The purpose of the Corporation and the nature of its business are as follows:

- To engage in the practice of dentistry and to provide services incident thereto.
- To do everything necessary, proper or convenient for the accomplishment of such purpose, and to do every other act incidental thereto which is lawfully permitted.

This Amendment shall be effective upon its filing with the Florida Department of State.

The foregoing Amendment to the Articles of Incorporation of the Corporation was adopted by the Corporation's sole incorporator by Written Consent, effective as of January 7, 1998. Shareholder action was not required.
