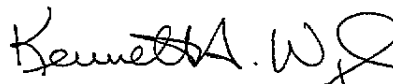

ARTICLES OF INCORPORATION
OF

ARTICLE 1

NAME

The name of this Corporation is U.K. PATTERNS, INC.

ARTICLE 2

PRINCIPAL PLACE OF BUSINESS

The principal place of business of this Corporation shall be

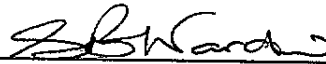
