ARTICLE I - NAME AND ADDRESS

The name and mailing address of the Corporation is Moncayo & Associates, CO 520 Brickell Key Drive, Apt. A-602, Miami, Florida 33131, respectively.

ARTICLE II - DURATION

The Corporation shall have a perpetual existence.

ARTICLE III - PURPOSE



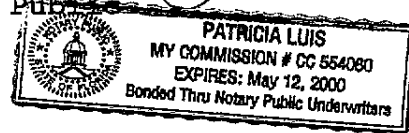
