The undersigned, acting as incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation.

Article I - Name

The name of this corporation is Broadway Corporation.

Article II - Principal Office and Mailing Address

The principal office and mailing address of the corporation is Atrium Financial Center, 1515 N. Federal Highway, Suite 310, Boca Raton, Florida 33432.

Article III - Authorized Shares
