Dollar(s) (\$ 0.00) par value Common Stock, which shall be designated "Common Shares."

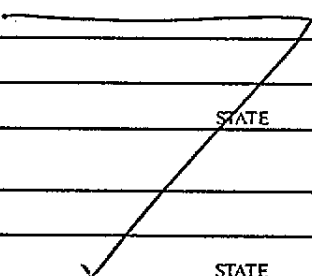

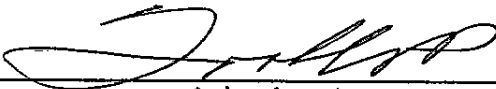
