

# ARTICLES OF INCORPORATION OF ALAN L. BRAUNSTEIN, Ph.D., P.A.



The undersigned, a natural person competent to contract, does hereby make, subscribe and file these Articles of Incorporation for the purpose of organizing a corporation under Chapter 607 of the laws of the State of Florida.

# **ARTICLE I**

### **CORPORATE NAME**

The name of this Corporation shall be:

## **ARTICLE II**

# NATURE OF CORPORATE BUSINESS AND POWERS

The general nature of the business to be transacted by this Corporation shall be to engage in every aspect of the business of rendering the same professional services to the public that a Psychologist, duly licensed under the laws of the State of Florida, is authorized to render. The professional services rendered by the Corporation may be rendered only through individuals duly licensed to render professional services as psychologists under the laws of the State of Florida as defined in Chapter 490, Florida Statutes. The Corporation shall not engage in any business other than the practice of psychology. 
