The undersigned, acting as incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

The name of the corporation is "SSE INVESTMENTS, INC."

ARTICLE II

The principal office and mailing address of this corporation is 800 Douglas Road, Suite 245, Coral Gables, Florida 33134.

ARTICLE III

The duration of this corporation is to be perpetual.

ARTICLE IV

The corporation may engage in any activity or business permitted under the laws of the State of Florida.

ARTICLE V

The corporation shall have authority to issue 10,000,000 shares, all of one class, \$.01 par value.

ARTICLE VI
