# ARTICLES OF INCORPORATION OF ILEANA POINTE, INC.

SECRETARY OF STATE TALLAHASSEE, FLORIDA

The undersigned subscriber to these articles of incorporation, being a natural person and competent to contract, hereby forms a Corporation for profit under the laws of the State of Florida.

#### ARTICLE I. NAME

The name of this Corporation is ILEANA POINTE, INC.

#### ARTICLE II. PURPOSE
