

ARTICLES OF INCORPORATION

ARTICLE I. NAME. The name of the corporation is LeVerrier Training Resources, Inc. with its principal place of business at 2931 St. Johns Ave., #3, Jacksonville, Florida 32205.

ARTICLE II. DURATION. LeVerrier Training Resources, Inc. will begin to exist on January 1, 1998 and the duration of the corporation is perpetual.
