The undersigned incorporator to these Articles of Incorporation hereby forms a corporation under the laws of the State of Florida as follows:

ARTICLE I
(Name)

The name of the Corporation is: Gohoke Incorporated.

ARTICLE II
(Term of Existence)

The date when corporate existence shall commence shall be the date of the filing of these Articles of Incorporation by the office of the Florida Department of State, and the Corporation shall have perpetual existence thereafter.

ARTICLE III
(Nature of Business)

The corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States of America, the State of Florida, or any other state, country, territory or nation.

ARTICLE IV
(Capital Stock)

The number of shares of stock that this Corporation is authorized to have outstanding at any one time is 10,000 shares of common stock having a par value of \$1.00 per share.

ARTICLE V
(Initial Registered Office and Agent)

The street address of the principal office and the initial registered office of the Corporation is 4100 W. Kennedy Blvd., Suite 210, Tampa, Florida 33609, and the name of its initial registered agent at such address is Paul T. Marks.

ARTICLE VI
(Directors)

The Corporation shall have one (1) director initially. The Corporation shall indemnify any director or officer or any former director or officer to the full extent permitted by law.


ARTICLE X

(Amendment)


These Articles of Incorporation may be amended in the manner provided by law.
