The undersigned, Mark S. Steinberg, for the purpose of forming a Professional Association pursuant to the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation.

ARTICLE I
NAME

The name of this corporation shall be Mark S. Steinberg, P.A.

ARTICLE II
CORPORATE OFFICES

The principal office from which business activity shall be held and at which mail may be received shall be 9719 South Dixie Highway Suite 17, Pinecrest, Florida 33156-2806.

ARTICLE III
CORPORATE DURATION

The existence of this corporation shall commence on the thirty-first day of December 1997 provided that if such day be unauthorized under law, then on the earliest day allowable pursuant to Florida Law for the commencement of corporate existence; and shall continue perpetually unless dissolved according to law.

PURPOSE OR PURPOSES

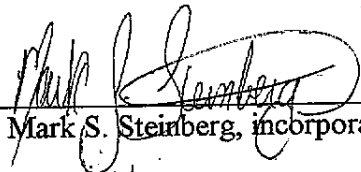
ARTICLE IX

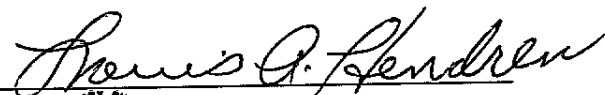

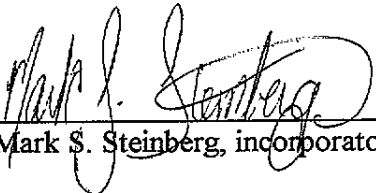

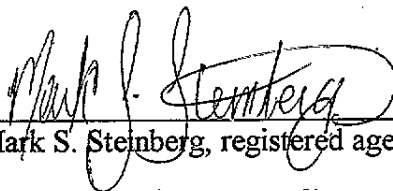
