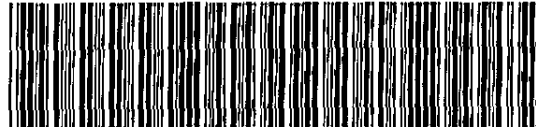

Upon the later of the filing of these Articles of Dissolution by the Secretary of State or December 31, 2004, the Corporation shall be effectively dissolved.


