Article I - Name

The name of the corporation is ROBERTSON'S AUTO & TRUCK  
INC.

Article II - Duration

The corporation shall have perpetual existence and this  
existence shall commence upon filing these Articles with the Secretary  
of State.

Article III - Purpose

This corporation is organized for the purpose of trans-  
acting any and all lawfull business.

Article IV - Capital Stock

This corporation is authorized to issue 100 shares of ONE  
(\$1.00) DOLLAR par value common stock which shall be designated  
"Common Shares."

Article V - Initial Registered Office and Agent
