ARTICLES OF INCORPORATION

OF

JODI B. LAURENCE, P.A.

The undersigned incorporator, for the purposes of forming a professional service corporation under Florida Statutes, Chapter 621, Professional Service Corporation Act, hereby adopts the following Articles of Incorporation:

- FIRST:** The name of the Corporation is Jodi B. Laurence, P.A. (the "Corporation").
- SECOND:** The principal office address and mailing address of the Corporation is 7777 Glades Road, Suite 300, Boca Raton, Florida 33434.
- THIRD:** The Corporation is authorized to issue 1000 shares of common stock, par value \$.01 per share. Shares of the Corporation's stock and certificates shall be issued only to lawyers in good standing and duly licensed or otherwise legally authorized within the State of Florida to render the same professional services as the Corporation.
- FOURTH:** The street address of the initial registered office of the Corporation is: 7777 Glades Road, Suite 300, Boca Raton, Florida 33434 and the registered agent at that address is: Jodi B. Laurence.
- FIFTH:** The name and address of the incorporator of the Corporation is: Jodi B. Laurence, 7777 Glades Road, Suite 300, Boca Raton, Florida 33434.
- SIXTH:** The Corporation is organized for the purpose of engaging in the practice of law in the State of Florida, and all its fields of specialization as engaged in by lawyers pursuant to Chapter 621, Professional Service Corporation Act. The Corporation shall engage and render the professional services involved only through its officers, agents and employees who shall be lawyers in good



EIGHTH: The Corporation expressly elects not to be governed by Section 607.0901 of the Florida Business Corporation Act, as amended from time to time, relating to affiliated transactions.

NINTH: The Corporation expressly elects not to be governed by Section 607.0902 of the Florida Business Corporation Act, as amended from time to time, relating to control share acquisitions.

TENTH: The corporate existence of the Corporation shall commence on January 1, 1998.


