### ARTICLES OF INCORPORATION

OF

The undersigned incorporator, for the purposes of forming a professional service corporation under Florida Statutes, Chapter 621, Professional Service Corporation Act, hereby adopts the following Articles of Incorporation:

FIRST:

The name of the Corporation is Jodi B. Laurence, P.A. (the "Corporation").

SECOND:

THIRD:

The Corporation is authorized to issue 1000 shares of common stock, par value \$.01 per share. The Corporation expressly elects not to be governed by Section 607.0902 of the Florida Business Corporation Act, as amended from time to time, relating to control share acquisitions.

TENTH:

The corporate existence of the Corporation shall commence on January 1, 1998.
