

ARTICLE I - NAME

The name of this corporation is NTM Services, Inc. (the "Corporation").

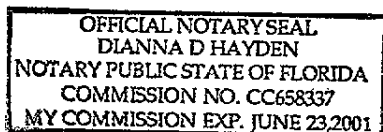
