
I, the undersigned, hereby files this Article of Correction in order to correct the misspelling of the corporate name in the Articles of Incorporation filed on January 8, 1998.

The correct name of the corporation is ARCHITECTURAL STUDIO, INC. which should be corrected in the title of the articles and in Article I.


