ARTICLES OF INCORPORATION

OF





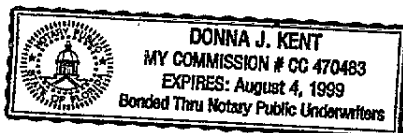
